

## Family Therapeutic Justice Certification Programme Frequently Asked Questions

- 1) What funding is available for the Oct 2021 run?
  - a. SkillsFuture Credits of up to \$1000 can be used on the Essential and Optional Modules (depending on how many credits a registrant has and wishes to use)
  - b. Skills Study Award covers the cost of the Essential and Optional Modules fully (depending on eligibility and successful application)
  - c. We are working on more avenues for funding and will update as these become available

- 4) What are the eligibility criteria for SkillsFuture Credit?
  - a. All Singapore Citizens aged 25 years and above will have received SkillsFuture Credits of up to \$1,000 that are eligible for use for this course.
  - b. Credits under the Career Transition is not claimable under this programme..
- 5) What are the eligibility criteria for SkillsFuture Study Award?
  - a. Singaporeans with at least 3 years of work experience in the Legal industry
  - b. Application is on a competitive basis as there are a limited number of Awards
  - c. Applicants should provide third-party documents such as CPF statements, employment letters or practising certificates as valid proof of their years of work experience
  - d. Applicants should demonstrate that they are committed to deepening skills in the Legal industry
  - e. Firms' nominations are highly encouraged. Firms should provide reasons for the nomination, details of the nominee's work performance, potential for the nominee's advancement in the company/sector, and explain how the course of study will help the nominee fulfil his or her current and future job requirements.
  - f. Applicants should provide proof of admission to the selected course of study
  - g. Applicants must not have completed the course of study at the point of application
  - h. Applicants cannot be a previous recipient of any SkillsFuture Study Award
  - i. Applicants should upload all supporting documents for their applications to be considered complete, only complete applications will be assessed
- 6) I cannot see the Family Therapeutic Justice Certification Programme listed on the SSG websites, what should I do?
  - a. The FTJCP is in the process of being formally uploaded to the relevant sites. We expect that the sites will be updated by the end of the week.

- 7) Can I register for the Elective Modules without registering for the Essentials Module?
  - a. We regret that at this time, you can only register for an Elective Module if you have registered for the Essential Module.
  - b. The Elective Modules do not have to be taken at the same time as the Essentials Module. If you have taken the Essentials Module, you may register to take future runs of the Elective Modules.
- 8) Will there be other runs of the course?
  - a. Yes, a second run of the course is scheduled for Feb 2022.
  - b. Thereafter, as long as there is a demand for the course, runs of the course sufficient to meet demand will be conducted.
- 9) What format is the course?
  - a. The course adopts a blended learning format comprising asynchronous 'on demand' learning videos, readings and quizzes, as well as synchronous face-to-face sessions both online and in person.
  - b. Please note that due to the fluid Covid-19 situation, in-person face-to-face sessions may be conducted virtually instead, at the sole discretion of the organisers.
